## Village Storm Water System



The Village Storm Water System is a separate system from the Villages Sanitary Sewer System. Storm Water System maintenance and cleaning is performed routinely by the Street Division. The Villages system flows from curb catch basin, yard drainage, and retention/detention ponds to streams and rivers. Please help us with the maintenance of the system by not discharging yard waste and pollution into the system.

Many times during rain events the curb basins become clogged by garbage and yard refuse and the clearing of the debris has to be undertaken to alleviate flooding of the roadways. By disposing of garbage and yard refuse properly you can assist us in easing the flooding of these catch basins.

If we all do our part in recycling of yard waste and properly dispose of garbage to help the environment and wild life, we will also assist in keeping the Villages waterways cleaner at the same time and ease the impact of flooding in our community. Remember that the storm water system flows to creeks and rivers, pollutants such as motor oil should not be dumped into catch basins.

The Village of Glendale Heights is seeking volunteers that wish to be involved in storm drain stenciling. Storm drain stenciling is a fun way to get a group of friends, scouts, club members, neighbors and co-workers together while spending time outside. You can spend as much or as little time as you have. It's so simple and flexible. The Public Works Department supplies everything you need at no charge to you and all we ask is that you fill out a form to tell us the number of drains stenciled, what was gathered and how many friends participated. Drain maps are available.



## Water Pollution Control

The IEPA initiated a Statewide Nutrient Reduction Strategy recently and it will affect the Village soon. Most Illinois wastewater plants will have to start planning on removing phosphorus before discharging in the receiving stream.

The impact of excess nitrogen and phosphorus in Illinois rivers, lakes, streams and the Gulf of Mexico is a very high profile water quality issue. Under the right conditions, nutrients can cause excessive algal blooms, low oxygen and nuisance conditions that adversely impact aquatic life, drinking water and recreational uses of the water.

## Illinois' Distracted Driver Cell Phone Ban and You

"The average text takes your eyes off the road for nearly 5 seconds.  
Don't become a statistic."

Effective January 1, 2014, Illinois enacted a ban on handheld electronic communication devices while operating motor vehicles. This law received much publicity in the media both prior to, and after its effective date, but since the Police Department consistently receives telephone calls with questions regarding cell phone use, we thought it might be helpful to answer some frequently asked questions.

**What is banned?** Illinois bans using handheld electronic communication devices (mobile phones) while operating a motor vehicle unless a hands-free device is used, or the phone is being operated in a voice-control mode. You may press one button to start the conversation, and one button to end the conversation, but everything in between has to be hands-free. Of course texting is not allowed at any time while operating a motor vehicle. This includes composing OR reading text messages.

**Are there any exceptions to the cell phone ban?** As with every law, there are always exceptions. The law does not ban the use of a handheld phone device while contacting 911 for an emergency, or if the driver has pulled over and parked on the shoulder of the road, or if the vehicle is stopped because normal traffic is being obstructed and the vehicle transmission is in the neutral or park position.

**What happens if I get caught using a cell phone while driving?** Violations for the new law are a \$75 fine for a first violation, \$100 for the second violation, \$125 for a third violation, and \$150 for subsequent violations. Additionally, second or subsequent convictions are moving violations. If you cause a crash while texting, it is a misdemeanor violation punishable by up to a \$2,500 fine and up to a year in jail. Should the crash involve a fatality, a violator faces up to a \$25,000 fine and up to three years in prison.

The Glendale Heights Police Department actively enforces this statute in the effort to further reduce the number of crashes occurring in the Village annually. Hopefully through education of the public we can gain further compliance to make the Village a safer place to travel.



## County Launches Heroin Prevention Website, Social Media Campaign

The DuPage Coalition Against Heroin recently launched a website and corresponding social media campaign to provide timely information and valuable resources to combat this growing problem.

The brand new website, [heroindupage.org](http://heroindupage.org), provides a variety of heroin facts and local resources, such as the drug's effects on the user, family and community; warning signs for parents to consider; local treatment options; and support for the addict and family members. The Coalition also launched a Facebook page, [facebook.com/heroindupage](https://www.facebook.com/heroindupage), and Twitter feed, [twitter.com/heroindupage](https://twitter.com/heroindupage), to coincide with the website.

The DuPage Coalition Against Heroin was formed to raise awareness and educate the public about the heroin epidemic DuPage County is facing. In 2013, there were 46 heroin overdose deaths in DuPage County. The County Board has allocated \$100,000 for this collaborative prevention campaign.

## Summer Time Barbecues

We all enjoy a barbecue, especially now that the weather is getting warmer. So before you fire up the grill for another season of outdoor cookouts, here are some important safety tips to remember:

- Don't ever add starter fluid or gasoline to an already lighted grill. Fire can follow the fluid back to the container and cause it to explode. To speed a slow fire, carefully tuck dry kindling under the charcoal.
- Make sure the grill is level and steady and keep a container of water nearby.
- Dispose of bags of damp or wet charcoal, as it can spontaneously combust. Dispose of the charcoal in a metal container with a tight fitting lid.
- If you smell or see a leak, turn off gas. In case of a fire close the cover immediately, turn off the gas and call 9-1-1.
- Never use ANY grill inside your home, garage or under an overhang.
- Check burner assembly for blockage such as cobwebs and rust.
- Open cover of gas and propane grills before igniting.
- Use long handle utensils.
- Do not repair tanks or valves yourself.
- Don't let children or pets play around a grill.
- Don't leave any grill unattended. A grill on a wood deck can quickly set the deck on fire.

## Selling Your Home?

The Village of Glendale Heights has a Real Estate Transfer Program which requires that within no less than 21 days prior to the sale, the seller shall submit an application for a Certificate of Compliance with the following documents:

1. A recent (one year or less) Plat of Survey of the property.
2. The Permanent Parcel Index Number of the property
3. A filing fee of \$100.00 for a single family house.
4. If the property is held in trust, a disclosure of the beneficiaries.

At the time of application, an inspection will be scheduled. An inspection report will be provided. When any corrective work is completed, a reinspection will be conducted or the purchaser may submit a Guarantee of Compliance and post an escrow to guarantee the completion of the work within 30 days.

A Transfer Tax shall be paid prior to transferring title to or assigning the beneficial interest in a land trust. The tax imposed is \$3.00 for every \$1,000.00 of value or fraction thereof. The following documents must be submitted with the application for Transfer Stamps:

1. A receipt of payment for the final water bill.
2. A copy of the Certificate of Compliance.
3. A copy of the original deed which may be signed by your attorney.
4. A copy of the State Declaration which may be signed by your attorney.

Upon approval of the application and supporting documents, issuance of the Certificate of Compliance, and payment of the Transfer Tax, the Village will issue tax stamps.

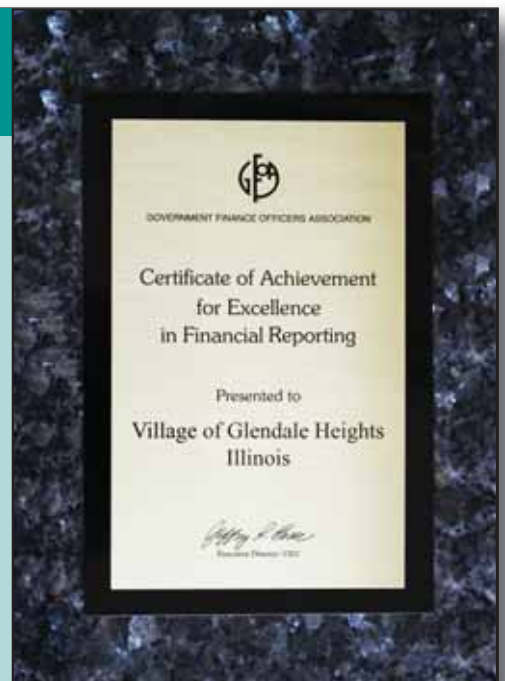


## Certificate of Achievement for Excellence in Financial Reporting

## Paint Reuse & Recycling Tips

**Got Paint?** Do you have paint left over and not sure what to do with it?

Below are some helpful reuse and recycling tips to better manage use of latex paint.

- When painting a room, buy the necessary amount needed for the project - look beyond what is on sale.
- Save left over paint in a glass jar that leaves almost no air space, and keep the paint for touch ups.
- Then, label the jar for which room the paint was used, or keep in the room itself, to ensure the correct paint will be used in the same room.
- Do not store paint in the garage. Once frozen, it is not reusable.
- Left over **unusable** latex paint should be consolidated into one container and dried with cat litter, sawdust or another absorbent material (i.e., oil absorbent).
- Once the paint is completely dry, it can be put out with regular garbage curb side pickup. Be sure to remove the lid on the paint can, so the waste hauler/driver can see that the paint is dry. Some haulers will not take the dried paint, unless the lid is off.
- For a small fee, some Ace Hardware stores are collecting latex paint to be re-blended and recycled into new latex paint. Visit [www.earthpaintscs.com/collection\\_center/search.php](http://www.earthpaintscs.com/collection_center/search.php) to find a paint recycling location near you.

### Oil Based Paint, Paint Thinners, Stain and Varnish Finishes are Toxic

Illinois residents are encouraged to drop-off unwanted, oil-based paint at the Regional Household Hazardous Waste Facility, located in Naperville. This is a drive through, drop-off facility open to everyone every Saturday and Sunday from 9:00 am - 2:00 pm (excluding Holidays).

## Source of Drinking Water

Lake Michigan water is supplied to the DuPage Water Commission from the City of Chicago. The City does all water filtration and treatment. The DuPage Water Commission adds chlorine and delivers the water through a series of water mains and storage tanks. The Village of Glendale Heights then delivers the water through several pump stations and storage tanks. The Village does not add chemicals to the water, but has the capabilities to do so.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the EPA's Safe Drinking Water Hotline 1.800.426.4791.

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or human activity.

## Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also, come from gas stations, urban storm water runoff and septic systems.
- Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water, which must provide the same protection for public health.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by Cryptosporidium and other microbial contaminants are available from the USEPA's Safe Drinking Water Hotline 1.800.426.4791.

**Source Water Location**

The City of Chicago utilizes Lake Michigan as its source water via two water treatment plants. The Jardine Water Purification Plant serves the northern areas of the City and suburbs, while the South Water Purification Plant serves the southern areas of the City and suburbs. Lake Michigan is the only Great Lake that is entirely contained within the United States. It borders Illinois, Indiana, Michigan, and Wisconsin, and is the second largest Great Lake by volume with 1,180 cubic miles of water and third largest by area.

**Susceptibility to Contamination**

The Illinois EPA considers all surface water sources of community water supply to be susceptible to potential pollution problems. The very nature of surface water allows contaminants to migrate into the intake with no protection only dilution. This is the reason for mandatory treatment for all surface water supplies in Illinois. Chicago's offshore intakes are located at a distance that shoreline impacts are not usually considered a factor on water quality. At certain times of the year, however, the potential for contamination exists due to wet-weather flows and river reversals. In addition, the placement of the crib structures may serve to attract waterfowl, gulls and terns that frequent the Great Lakes area, thereby concentrating fecal deposits at the intake and thus compromising the source water quality. Conversely, the shore intakes are highly susceptible to storm water runoff, marinas and shoreline point sources due to the influx of groundwater to the lake.

**2013 Voluntary Monitoring**

The City of Chicago has continued monitoring for Cryptosporidium, Giardia and E. Coli in its source water as part of its water quality program. To date, Cryptosporidium has not been detected in these samples, but Giardia was detected in 2010 in one raw lake water sample collected in September 2010. Treatment processes have been optimized to provide effective barriers for removal of Cryptosporidium oocysts and Giardia cysts in the source water, effectively removing these organisms in the treatment process. By maintaining low turbidity through the removal of particles from the water, the possibility of Cryptosporidium and Giardia organisms getting into the drinking water system is greatly reduced.

In 2013, Chicago Department of Water Management (CDWM) has also continued monitoring for hexavalent chromium, also known as chromium-6. USEPA has not yet established a standard for chromium-6, a contaminant of concern which has both natural and industrial sources. **GLENDALE HEIGHTS STAND-BY WELLS**

The Village of Glendale Heights' Stand-by Wells have been maintained in accordance with IEPA testing requirements and standards and are for emergency purposes only. The four Well sites are operated and tested without supplementing the Lake Michigan Water that we purchase and distribute from the DuPage Water Commission.

Inorganic Compounds are tests performed for stand-by wells, **which are not connected** to the distribution system and are for emergency purposes only.

\*Arsenic –While your drinking water meets EPA standards for arsenic, it does contain low levels of arsenic. EPA's standard balances the current understanding of arsenic's possible health effects against the cost of removing arsenic from drinking water. The EPA continues to research the health effects of low levels of arsenic, which is a mineral known to cause cancer in humans at high concentrations and is linked to other health effects such as skin damage and circulatory problems.
