LATE FEES

All license renewals <u>MUST</u> be filled out in entirety and returned to the Village with the appropriate fees before <u>January 1st</u>. Beginning February 1st, late fees will be assessed as follows:

February 1st	25% plus regular License Fee
March 1 st	50% plus regular License Fee

If license fee and late fees are not received on or before the 31st of March, the license can be revoked and tickets will be issued.
