## Valentines for Veterans


Collecting Valentines Day Cards to honor our veterans Cards due: February 5

## Senior Citizen Utility Tax Rebate Program

Since 1995, the Village of Glendale Heights has offered a Senior Citizen Utility Tax Rebate Program to qualifying seniors. The program has provided limited financial assistance to hundreds of senior residents.

The program offers a flat \$75 rebate to applicants for Municipal Utility Taxes paid in calendar year 2019 for electric, natural gas, telephone or cell phone bills. In order to qualify for the rebate, participants must be age 65 or older on or before December 31, 2019, or have a spouse who is 65; been a resident of the Village of Glendale Heights (owner or renter) all of 2019; have a qualifying gross income of no more than \$40,000 as evidenced by your 2019 Federal Income Tax Return or other suitable documentation; and be able to show proof that the utilities are billed in your name.

## Senior Citizen Utility Tax Rebate Program

To apply, you can pick up an application at the Center for Senior Citizens or Village Hall. If you prefer, an application can be mailed to your residence. Applications will also be available on the Village website beginning January 2, 2020.

Required documentation includes:

- A completed & signed application form. Applications will be accepted beginning February 1, 2020 and must be submitted no later than April 30, 2020.
- Proof of the following: age, residency, gross income and payment of utilities.
- Acceptable documents for proof of age include: Driver's License, Birth Certificate, or other acceptable forms of ID.
- Acceptable documents for proof of residency include: current property tax bill paid in 2019, current lease or rental agreement for the address for which reimbursement is requested.
- Name must be the same as rebate application and ID.
- Acceptable documents for proof of gross income include: 2019 Federal Income Tax Return (Form 1040 or 1040A), 2019 Form SSA-1099 Social Security Benefit Statement.
- A utility bill covering service in either November or December 2019 is required to obtain a rebate.

If you have any questions, call the Center for Senior Citizens at 630.260.6050 or the Finance Department at 630.909.5342. Reimbursements will be made within 30 days following receipt of a completed and verified application.

## A New Years' Resolution from the Village President and Board of Trustees

Although property tax bills are still several months away from arriving in mailboxes, residents and businesses within the Village will be pleased to learn that there has been no increase to the Village's tax levy for 2020. By law, the Village was required to file its annual tax levy requirements to the County before the end of December 2019. With a strengthening national, state and local economy, and a continued dedication of fiscal responsibility, the Village was once again able to hold the line on the tax levy. Since 2008, the Village's tax levy has gone up by an aggregate of 5.9%. Compare that to School District tax levies (which comprise nearly three-quarters of the overall tax burden) for the same time span as shown below:

Keep in mind when looking over your tax bill that the Village's share can generally be seen towards the middle of the bill. On average, only about 10.63% of the total tax bill comes from the Village. Questions concerning Village taxes can be directed to the Finance Department at 630.909.5342.

## Fleets Division

The Fleets Division takes great pride in assuring all snow fighting equipment is ready to perform the task of keeping the streets and walkways free of snow and ice. It is the goal of the Fleets Division to calibrate each truck to put down enough salt to melt snow and ice but not overly salt in order to preserve the environment. Please remember to keep a safe distance between you and the snow fighting equipment. Plow trucks are considered emergency equipment and have the right of way on our roads.

Here are some winter weather driving tips:

- Always brake gently on snow covered roads and drive slower
- · Install a new set of wiper blades if needed
- Keep your fuel tank full. In case you get stuck in the snow you will be able to stay warm.
- Keep a blanket in your vehicle
- Check your tire pressures once a month. The cold weather will affect tire pressure.
- Check and replace your tires if they are low on tread
- Have your vehicle battery tested to make sure it's fully charged. A weak battery will lead to a no start in extreme weather.

### Cold Weather at the WPCF

Cold weather can slow the activity of many things: people, water, and even bacteria. This can be a major problem for the Water Pollution Control Facility that relies on bacteria in the sludge to digest the organic load in wastewater. At colder temperatures, it takes bacteria longer to grow and metabolize food. Due to the drop in activity, the waste treatment processes will be greatly slowed if the amount of bacteria is not adjusted. Adjustments to the pumping rates of the return and waste activated sludge will be used to create a larger population of microorganisms in the system therefore resolving the issue!

## **Preventing Freezing Pipes**

With the winter months upon us, it becomes important to remember to protect water and sewer systems that service the inside of your business or residence. Freezing water or drain pipes in a building are not just inconvenient, but frozen pipes can burst risking serious water damage and even toxic mold growth. The most extreme water and mold damage to buildings occurs when the pipes burst in unoccupied structures whose conditions are not being monitored, such as a house for sale, vacancy or weekend home. Other cold weather damage in addition to frozen pipes includes cracked plaster in older homes or cracked and dislocated wood flooring.

Decide if you need a professional to winterize your building and/or monitor it during the time period it will be vacated. In some locales, companies offer winterized building protection services that range from weekly or even daily visits to check on a property. Services can also include an emergency response to a no-heat or water alarm initiated by home security systems. If power outages are common in the area, a battery-backup for alarms and sump pumps can be a smart addition to the building.

In the case of building piping, mechanical systems, or other components that are subject to freezing, it is important to identify areas of cold air infiltration. Identify drafts and cold spots and seal these areas using insulation or adding a heat source to prevent freezing.

## Stormwater Detention Project

A highlight of this year's construction season was the Salt Creek BBQ Underground Stormwater Storage Project. The Village previously demolished the former Salt Creek BBQ restaurant, which was flood prone and repeatedly damaged from flooding. In the summer of 2019, the Village replaced it with underground stormwater detention to reduce flooding. Several large pipes were connected to the Village's storm sewer system and buried underneath the ground. Afterwards, the large detention area was backfilled with stone. The project was surfaced with asphalt pavement and striped for parking, so that it seamlessly fits into the surrounding area. The project was paid for in part with a federal Community Development Block Grant as administered by DuPage County. The Village will receive more than \$330,000 in reimbursement due to the grant.

## Warming Shelters and CodeRED

The Glendale Heights Police Department is asking residents to please check on their relatives and friends to assure they are not in need of assistance due to extreme weather conditions. Glendale Heights has a warming shelter in place and is ready to assist the needs of our residents. The Village also offers CodeRED, a free service which could check on relatives and friends for you.

CodeRed allows the Police Department to communicate emergency situations, senior well-being checks, event reminders, and other relevant information instantly via pre-recorded emergency telephone notification/information messages. To sign up for CodeRED, log onto the Village's website and follow the emergency notification links to the "CodeRED Residential and Business Data Collection" page. Those without Internet access may call the Glendale Heights Police Department at 630.260.6070 to give their information over the phone. Forms are also available at Village Hall. ## Winter Car Safety Checklist

You never know when you could get stranded in your car. To be better prepared, keep the following recommended items in your car in the event of an emergency:

- Flares / Reflectors
- Shovel
- Tire Chains
- First Aid Kit
- Booster Cables
- Flashlight
- Blanket
- Scraper
- Spare Batteries
- Sleeping Bag
- Snow Brush
- Non-Perishable Food
- Matches / Lighter / Candle
- Coat / Gloves / Hat
- Sand / Gravel / Traction Mats

## Emergency Preparedness

The Bloomingdale and Glenside
Fire Protection Districts and the
National Fire Protection Association
(NFPA) would like to remind you that in a
disaster, local officials and relief workers
cannot reach everyone immediately. It's
important to be prepared ahead of time
because you won't have time to shop
or search for the supplies you will need
when a disaster strikes.

Most disasters are natural disasters, the result of some force of nature, such as tornadoes and floods. A disaster plan will help with safety, security, and comfort. Regardless of the type of disaster, there are things you can do to prepare. Contact your local Red Cross chapter or visit the FEMA website to make sure you are aware of the potential for natural disasters in your community. After you have identified the types of disasters that could strike where you live, create a family disaster plan. Remember to make it simple so everyone can remember the details.

#### **General preparedness:**

- Discuss what to do in an evacuation, and don't forget to include the needs of those with disabilities.
- When told by officials, go immediately to a shelter as instructed or to the home of a friend or relative who lives out of the area. Find out about your local shelters beforehand.
- Know evacuation routes. Pre-establish several different routes in case certain roads are blocked or closed.
- Family members can become separated during an emergency. Be prepared by creating a plan for how to reach one another.
- Quiz children every six months so they remember what to do, where to go, and whom to call in an emergency.
- Decide how to take care of pets. Pets are not allowed in places where food is served, so you will need to have a place to take your pets if you have to go to a shelter.

## Flood Insurance Rate Map Information Service

As a free public service to lending institutions, real estate and insurance agents, and residents, the Village's Community Development staff provides the following flood information upon request:

- Whether a property is located within a floodplain or floodway, as indicated on the Village's Special Flood Hazard Insurance Rate Map (FIRM).
- Site specific data such as the designated flood zone and the base flood elevation of the subject property.
- Elevation certificates for individual properties.
- Information on other problem flood areas outside the floodplain, drainage problems, or other historical flooding data may be available for your property.
- Information is also available on flood proofing and flood protection for your home or property located in the Special Flood Hazard Area.

Village residents may also visit the Glenside Public Library for this information. The Village's Community Development Department has reference flood maps and flood protection information resources available for viewing. If you have any flooding or drainage concerns, please contact the Community Development Department at 630.260.6030.

**Flood insurance:** If you do not have flood insurance, talk to your insurance agent. Homeowner's insurance policies do not cover flood damage. However, because Glendale Heights participates in the National Flood Insurance Program, you may be able to purchase a separate flood insurance policy at a reduced rate. This insurance is backed by the Federal Government and is available to everyone including owners of properties that have previously flooded.

Some people have purchased flood insurance because it was required by the bank when they received a mortgage or home improvement loan. Usually these policies just cover the building's structure and not its contents. In a typical flood, there is usually more damage to furniture and contents than there is to the structure.

If you currently have flood insurance, reference the policy to make sure you have adequate coverage for contents. Remember, even if the last flood missed you or you have done some flood proofing, the next flood could be worse. Flood insurance covers all surface floods.

When making a flood insurance map zone inquiry, please have the street address of the specific property or properties. To make an inquiry, please call the Community Development Department Monday through Friday between 8:00 am and 4:30 pm at 630.260.6030.
