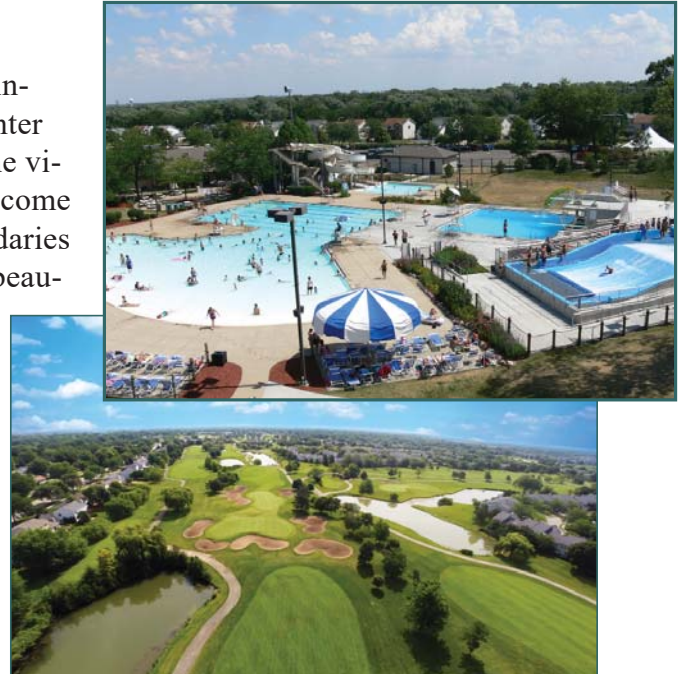

The Village of Glendale Heights is a modern residential, suburban community, 15 miles west of the Chicago city limits. Over the years, the Village has welcomed a significant growth, both in population, and within our business community. The current population is 34,208 as of the 2010 census. Village Government



The Village of Glendale Heights was incorporated in July of 1959. The first election was held on August 2, 1959. Though incorporated as Glendale, the name was changed to Glendale Heights in March 1960 because of a conflict with another Glendale in southern Illinois. The name chosen is appropriate for “Glendale” as it reflects a close geographic identity with two neighbors, Glen Ellyn to the south and Bloomingdale to the north. “Heights” describes the unique topography of the Village as it rests on two distinct elevations with a 100-foot variation.

The Village is a home rule municipality under the Constitution of the State of Illinois and is governed by a Village President and 6 Village District Trustees. The elected officials serve alternating four-year terms.

The Village of Glendale Heights has over 300 employees making up several departments which include, Administration; Police; Parks, Recreation & Facilities; Public Services; Finance; Administrative Services; Community Development; and Glendale Lakes Golf Club.

Seasonal Youth Coordinator (Hourly Rate Range \$10.00 - \$13.65)

We are seeking an energetic, hardworking, and responsible staff members to work in the operation and coordination of the summer day camp programs. This position supervises the Youth Program Counselors. Current certification, or an acceptable equivalent, in Standard First Aid and CPR. High school diploma and two year's of college level courses, 2 year's recreation experience, including community center programming or a combination of education and experience required.

Seasonal Youth Program Counselor (Hourly Rate Range \$8.25 - \$9.75)

We are looking for energetic, hardworking, and responsible staff members who can guide and instruct children in our youth programs, including dance, drama, crafts, games and sports. Current certification, or an acceptable equivalent, in Standard First Aid and CPR is a plus. This position is ideal for recreation/leisure and education majors.

Pool Manager (\$13.00-\$15.00)

The Pool Manager performs administrative, supervisory and professional work in the operation and maintenance of a swimming pool and in coordinating various aquatics programs in a leadership role. The Pool Manager manages and supervises assigned operations to achieve goals within available resources; plans and organizes workloads and staff assignments; trains, motivates and evaluates assigned staff; reviews progress and directs changes as needed. Qualified applicants must be Lifeguard Training Certified. This applicant must also have four years experience at a public pool, be First Aid and CPR certified, have skill in the operation of specified tools and equipment, and have considerable knowledge of recreation philosophy in regards to an aquatic environment and techniques used in an aquatic community recreation program.

Aquatic Facility Coordinator (Hourly Rate Range \$10.00 - \$13.65)

We are seeking an energetic, hardworking, and responsible staff member to oversee the operation and maintenance of a swimming pool and its various aquatics programs. This position supervises part time recreation staff, lifeguards, instructors, seasonal employees, and volunteers, as assigned. Starfish/Starguard certification or an acceptable equivalent in Standard First Aid and CPR; water safety and lifeguard certification training.

Swim Coach (Hourly Rate Range \$10.00 - \$13.65)

The Glendale Heights Dolphins Swim Team needs reliable swim coaches to lead the team's practices and swim meets. The coach is responsible for coordinating swim and land-based workouts, developing meet line-ups, and tracking individual swimmers' progress for swimmers who range in age from 6 to 18 years old. Must have prior experience in competitive swimming and a current CPR/First Aid certification (or be willing to obtain before practices begin).

Lifeguard/Swim Instructors (Hourly Rate Range \$9.00 - \$10.00)

We are seeking responsible, team-oriented lifeguards and swim instructors to work at our Aquatic Center. Applicants must pass a Village-sponsored lifeguard certification class before employment begins. This position is ideal for recreation/leisure majors.

Seasonal Laborer (Hourly Salary Range \$10.00 - \$12.00)

Seeking applicants for performing a variety of skilled and semiskilled grounds maintenance work and construction work, and operating a variety of equipment in the operation, repair and maintenance of Village buildings and grounds. Qualified applicant must be able to read and have the ability to work diligently with team spirit and have a basic knowledge of the use and application of hand tools and some power tools. Most assignments require physical stamina, heavy lifting of up to 100 pounds and sometimes working in inclement weather conditions. Valid driver's license required.

Seasonal Recreation Attendant (\$8.25 - \$10.00)

The Seasonal Recreation Attendant is responsible for assisting in the operation and programming of the gymnasium, racquetball courts, tennis courts, concession stands and multi-purpose field located at the assigned recreational facility. Seasonal Recreation Attendants regularly serve as score keeper for a variety of recreation sports and can serve as program leaders.

Head Swim Coach (\$13.00 – 15.00)

The Head Swim Coach performs supervisory and professional work in the operation of the swim team program in a leadership role. The Head Swim Coach provides leadership and direction in the development of short and long-range plans; acts as a role model to the team participants and provides instruction on stroke techniques and mechanics. Qualified applicants must have previous experience in competitive swimming; working knowledge of the equipment, facilities, operations, and techniques used in a swim team program; skill in operation of specialized tools and equipment and must be First Aid and CPR certified.
