I am pleased to report that the Village of Glendale Heights General Fund is expected to end its 2015/2016 fiscal year in the black which will result in an increase to our reserve funds. The Village's excellent Aa2 bond rating was recently affirmed during an annual review by Moody's Investors Service. Moody's noted the Village's strong financial position as a key factor in affirming it's rating.

The warm weather is a reminder to stop by the GH₂O Aquatic Center to cool off. We have been busier than ever with people of all ages trying out the FlowRider and flying down the slides as they splash into the cool water. The GH₂O Aquatic Center offers regular daily rates along with resident, non-resident and senior citizen rates. We also offer swim lessons and numerous special events throughout the season.

Glendale Heights Fest returns once again with fast paced rides, rocking music, delicious food, and our breathtaking fireworks display that seems to get better and better each year. 



Water Conservation

Residents, property owners, renters, or property managers are reminded that on May 1st, the Village of Glendale Heights began its Outdoor Water Usage Schedule for water conservation measures per Title 9-2-3 of the Village Code, whereby persons or entities owning or controlling property in the Village may use water for outdoor water sprinkling and/or other large consumption purposes on designated days and times. This schedule shall remain in effect until September 30. Unless otherwise provided, the following outdoor water usage schedule shall apply:

- Outdoor water use is permitted between 6:00 am - 10:00 am & between the hours of 6:00 pm - 10:00 pm.
- Odd number street addresses are permitted to water on odd days of the month.
- Even number street addresses are permitted to water on even days of the month.

Street Division

Motorists traveling Glendale Heights' roads are asked to recognize the importance of slowing down in work zones. Motorists should drive with focus as they approach, enter and travel through work zones for their own safety and the safety of others. Distracted driving contributes to 25% of all police reported traffic crashes according to the National Highway Traffic Safety Administration (NHTSA). Be patient as most of the time work zones require lane closures. Remain alert in case you need to slow down or stop due to traffic or construction work.



Fullerton Ave. Road Construction

A major road project is being undertaken through the Community Development Block Grant (CDBG) project, which uses in part, grant money administered by DuPage County. This road project involves the reconstruction of Fullerton Avenue east of Glenn Ellyn Road and resurfacing of Fullerton Court. Construction began June 20, 2016 and is scheduled to be completed, weather dependent, the week of August 22, 2016.

Summer Tire Tips

Checking your tires is crucial in the summer. Long road trips with heavy loads and high temperatures can stress your tires to the max. Make sure that you have the correct amount of tire pressure in your tires at all times.



Also, don't forget to check the spare. Over time, the spare loses air and won't be much use if flat.

G. Stanley Hall School Tours the Water Pollution Control Facility

As part of National Public Works Week, on May 20, 2016, the WPCF hosted G. Stanley Hall School for their annual 5th grade tour. It is a very popular event for the students as they learn about the entire water treatment process. They even get an opportunity to look under a microscope at the microorganisms that helps process the waste. In addition, students learn that the water discharged into the East Branch of the DuPage River is cleaner than the river water.

Glendale Heights Cooling Shelters

As you know, the summer months can bring extremely hot temperatures and dangerously high humidity to the area. Small children, senior citizens, and persons suffering illness or disability are especially vulnerable to extreme heat and humidity. The Glendale Heights Police Department is asking residents to please check on their relatives, friends, and neighbors to ensure their well-being and safety. During these long hot summer days, please be reminded of the following tips for staying cool this summer:

- Be aware of the heat. Pay attention to it, and modify your activities appropriately
- Pay attention to your hydration status, and be sure to drink plenty of fluids
- Try to stay in relatively cool areas, even when outside. Many public places such as libraries, shopping malls and movie theatres are air conditioned.
- Avoid hot enclosed places, such as cars. Never leave children unattended in a car parked in the sun.
- Use a fan, if available
- Stay on the lowest floor of your building
- Eat well-balanced, light, regular meals
- Wear loose-fitting, lightweight, light-colored clothing
- Cover windows that receive a significant amount of sun with drapes or shades to help keep your house cool
- Weather stripping and proper insulation will keep cool air inside your home
- Cool beverages are good for cooling down the body, while alcoholic drinks can impair the body's ability to regulate its temperature

Glendale Heights will activate a temporary cooling shelter to assist our community when weather conditions present such a need. For additional information about cooling shelters, please call the Police Department's non-emergency number at 630.260.6070 and as a reminder, in ANY emergency you are encouraged to call 9-1-1 for immediate assistance.

Tele-Fraud Tips

- Be skeptical of offers that sound "too good to be true" they usually are.
- Resist high-pressure sales tactics. Don't allow yourself to be hurried into a decision.
- Do not give your credit card number or checking account information to anyone over the phone unless you know with whom you are dealing.
- Don't spend or invest more than you can afford to lose.
- Companies should be willing to provide their name, address, phone number and references. If not, be skeptical and verify their information before making a purchase.
- If you are skeptical about a company, check with the Better Business Bureau before you make a purchase.

Report incidents of telemarketing fraud to your local Better Business Bureau or the Police Department.



Fireworks Safety



Fireworks are often used to mark special events and holidays. However, they are not safe in the hands of consumers. The Bloomington and Glenside Fire Protection Districts and the National Fire Protection Association (NFPA) are opposed to consumer use of fireworks, and the **use of fireworks is illegal in Illinois!** Fireworks cause thousands of burns and eye injuries each year. Even sparklers burn hot enough to cause third-degree burns. People can enjoy the holidays if they remember the following:

- Fireworks cause an average of almost 20,000 reported fires per year.
- In 2013, sparklers caused 41% of fireworks injuries.
- Be safe. If you want to see fireworks, go to a public show put on by experts.
- Do not use consumer fireworks.
- Keep a close eye on children at events where fireworks are used.

Crime Prevention Tips

As with most crimes, PURSE & WALLET THEFTS are a crime of opportunity. Criminals are attracted to targets that are easy and inviting. Your best defense is to take steps to make your property uninviting to criminals. In other words, the harder you make it, the less likely you are to become a crime victim. Purse/wallet thefts lead to various other crimes such as Credit Card Fraud, Forgery and Identity Theft. Below are a few theft prevention tips:

- When shopping, do not leave your purse/wallet unattended.
- Carry money, identification and credit cards in your pocket.
- Always keep your purse/wallet closed.
- Do not keep your Personal Identification Numbers (PIN) in your purse/wallet.
- Keep your car keys and your house keys on two separate key rings.
- Don't carry large amounts of cash.
- Keep a list or photocopy of all credit and identification cards.
- Do not put your social security card in your purse/wallet.
- Do not leave your purse in plain view in your car.

The Glendale Heights Police Department will host their 19th Citizen's Police Academy. The program taught by officers from the Glendale Heights Police Department along with guest instructors from other agencies, is designed to give residents a realistic view of police work by providing instruction on various police topics.

A minimum enrollment of 10 students is required to hold the Academy, and the maximum class size will be limited to 24 students.

Enrollment is free. Citizens 18 years of age or older who live or work in Glendale Heights are invited to attend. *Note: Due to the nature of the course and curriculum, individuals with prior felony arrests or convictions will be declined.

Applications for enrollment are due no later than August 26, 2016. Applications can also be downloaded and printed from the Village website, but must be dropped off or mailed to the Police Department once completed.

Paint Reuse & Recycling Tips

Got Paint? Do you have paint leftover and are not sure what to do with it?

Latex paint

Latex Paint is not a hazardous material and therefore may be discarded in the trash when properly prepared per Republic Services requirements for residential curbside collections. Residents must mix in sand, dirt, kitty litter or oil dry to soak up the paint, until the substance has turned into a dry paste and hardened. The can should then be placed next to the cart/tote, with the top off. This allows the driver to verify that the material has been prepared properly. Once the driver confirms that the material is suitable for disposal, it will be placed in the carts. Failure to adhere to this protocol poses a safety hazard to the driver and to the community it serves. For further questions, you may contact Republic Services (847) 981.0091.

Oil Based Paint, Paint Thinners, Stain and Varnish Finishes are Toxic.

This is a drive through, drop-off facility, open every Saturday and Sunday from 9:00 am- 2:00 pm, excluding Holidays. When painting a room, buy what you need and not just what is on sale. Save leftover paint in a glass jar with minimal air space for touch ups. Label the jar for which room the paint was used or keep in the room itself. Do not store paint in the garage -once frozen it is not reusable.

Selling Your Home

If you decide to sell your home in Glendale Heights, here are some steps that will help you in the process! First off, you are required to obtain a real estate transfer stamp, which may be done by following these simple steps:

1. Submit a completed Real Estate Transfer Certificate of Compliance Application a minimum of 21 days prior to closing, which is available online or at Village Hall.
2. Submit an inspection application fee of \$100.00 for a single family home.
3. An inspection will be scheduled when the application and fee is submitted.
4. When the inspection is conducted, you will be provided with a report of any items that need to be corrected. You may make the corrections and have a re-inspection, or the purchaser may sign a Guarantee of Compliance and post an escrow to guarantee that the work will be completed within 30 days.
5. A plat of survey of the property less than a year old must be submitted as part of the inspection process.
6. Once the inspection passes or the Guarantee of Compliance is signed and escrow posted, you may submit an application for the Transfer Stamp along with the following documentation:
 - a. Payment of the transfer tax prior to transferring title to or assigning the beneficial interest in a land trust. The fee is \$3.00 for every \$1,000.00 of value or fraction thereof.
 - b. A receipt of payment of the final water bill.
 - c. A copy of the original deed, which may be signed by your attorney.
 - d. A copy of the State Declaration, which may be signed by your attorney.

Once the fees and taxes are paid and the documentation is submitted, the Village will issue the tax stamp. For more information on this process, please contact Community Development at 630.260.6030.

We are pleased to report that The Village of Glendale Heights' drinking water had no violations or exceeded any other water quality standard. No drinking water quality violations were recorded during 2015.

We want our valued customers to be informed about their water quality. If you would like to learn more, please feel welcome to attend any of our regularly scheduled Village Board meetings every first and third Thursday of the month. The meetings are held at Village Hall, 300 Civic Center Plaza, and begin at 7:30 p.m. You can also attend the DuPage Water Commission meetings. Source of Drinking Water

Lake Michigan water is supplied to the DuPage Water Commission from the City of Chicago. The City does all water filtration and treatment. The DuPage Water Commission adds chlorine and delivers the water through a series of water mains and storage tanks. The Village of Glendale Heights then delivers the water through several pump stations and storage tanks. The Village does not add chemicals to the water, but has the capabilities to do so.

The Illinois EPA considers all surface water sources of public water supply susceptible to potential pollution problems. Hence the reason for mandatory treatment of all public water supplies in Illinois. Mandatory treatment includes coagulation, sedimentation, filtration and disinfection. Primary sources of pollution in Illinois lakes can include agricultural runoff, land disposal (septic systems) and shoreline erosion.

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or human activity.

Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems.
- Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the EPA's Safe Drinking Water Hotline 1 (800) 426 4791.

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water, which must provide the same protection for public health.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by Cryptosporidium and other microbial contaminants are available from the Safe Drinking Water Hotline 1 (800) 426 4791.

Source Water Location

The City of Chicago utilizes Lake Michigan as its source water via two water treatment plants. The Jardine Water Purification Plant serves the northern areas of the City and suburbs, while the South Water Purification Plant serves the southern areas of the City and suburbs. Lake Michigan is the only Great Lake that is entirely contained within the United States. It borders Illinois, Indiana, Michigan, and Wisconsin, and is the second largest Great Lake by volume with 1,180 cubic miles of water and third largest by area.

Source Water Assessment Summary

The Illinois EPA implemented a Source Water Assessment Program (SWAP) to assist with watershed protection of public drinking water supplies. The SWAP inventories potential sources of contamination and determined the susceptibility of the source water to contamination. The Illinois EPA has completed the Source Water Assessment Program for our supply. Further information on the City of Chicago's water supply's Source Water Assessment Program is available by calling the City of Chicago, Department of Water Management at 312-744-6635.

Susceptibility to Contamination

The Illinois EPA considers all surface water sources of community water supply to be susceptible to potential pollution problems. The very nature of surface water allows contaminants to migrate into the intake with no protection only dilution. This is the reason for mandatory treatment of all surface water supplies in Illinois. Chicago's offshore intakes are located at a distance that shoreline impacts are not usually considered a factor on water quality. At certain times of the year, however, the potential for contamination exists due to wet-weather flows and river reversals. In addition, the placement of the crib structures may serve to attract waterfowl, gulls and terns that frequent the Great Lakes area, thereby concentrating fecal deposits at the intake and thus compromising the source water quality. Conversely, the shore intakes are highly susceptible to storm water runoff, marinas and shoreline point sources due to the influx of groundwater to the lake.

2015 Voluntary Monitoring

The City of Chicago has continued monitoring for Cryptosporidium, Giardia and E. Coli in its source water as part of its water quality program. To date, Cryptosporidium has not been detected in these samples, but Giardia was detected in 2010 in one raw lake water sample collected in September 2010. Treatment processes have been optimized to provide effective barriers for removal of Cryptosporidium oocysts and Giardia cysts in the source water, effectively removing these organisms in the treatment process. By maintaining low turbidity through the removal of particles from the water, the possibility of Cryptosporidium and Giardia organisms getting into the drinking water system is greatly reduced. Also, in compliance with Long Term 2 Enhanced Surface Water Treatment Rule (LT2ESWTR) Round 2, the City of Chicago has started the 24 months long monitoring program in April 2015, collecting samples from its source water once per month to monitor for Cryptosporidium, Giardia, E. coli and turbidity. Cryptosporidium and Giardia were not detected in these samples.

In 2015, Chicago Department of Water Management (CDWM) has also continued monitoring for hexavalent chromium, also known as chromium-6. USEPA has not yet established a standard for chromium-6, a contaminant of concern which has both natural and industrial sources. Turbidity

Turbidity is a measure of the cloudiness of the water. We monitor it because it is a good indicator of water quality and the effectiveness of our filtration system and disinfectants.

Unregulated Contaminants

A maximum contaminant level (MCL) for this contaminant has not been established by either state or federal regulations, nor has mandatory health effects language. The purpose for monitoring this contaminant is to assist USEPA in determining the occurrence of unregulated contaminants in drinking water, and whether future regulation is warranted.

Sodium

There is no state or federal MCL for sodium. Monitoring is required to provide information to consumers and health officials who have concerns about sodium intake due to dietary precautions. If you are on a sodium-restricted diet, you should consult a physician about the level of sodium in the water.

Fluoride

Fluoride is added to the water supply to help promote strong teeth. The Illinois Department of Public Health recommends an optimal fluoride range of 0.9 mg/l to 1.2 mg/l until November 2015. As of November 2015, the new recommendation is an optimal fluoride level of 0.7 mg/l

UCMR3 Compliance Reporting

In compliance with the Unregulated Contaminant Monitoring Rule 3 (UCMR3) as required by the EPA, the City of Chicago has monitored for 28 contaminants suspected to be present in drinking water, but that do not have health-based standards set under the Safe Drinking Water Act. The monitoring results were reported to the EPA. The list of UCMR3 contaminants that we have monitored included volatile organic chemicals, metals, perfluorinated compounds, hormones, 1, 4-dioxane and chlorate. The contaminants that were detected in this monitoring program are listed below.

GLENDALE HEIGHTS STAND-BY WELLS

The Village of Glendale Heights' Stand-by Wells have been maintained in accordance with IEPA testing requirements and standards and are for emergency purposes only. The four Well sites are operated and tested without supplementing the Lake Michigan Water that we purchase and distribute from the DuPage Water Commission.

Inorganic Compounds are tests performed for stand-by wells, **which are not connected** to the distribution system and are for emergency purposes only.

*Arsenic –While your drinking water meets EPA standards for arsenic, it does contain low levels of arsenic. EPA's standard balances the current understanding of arsenic's possible health effects against the cost of removing arsenic from drinking water. The EPA continues to research the health effects of low levels of arsenic, which is a mineral known to cause cancer in humans at high concentrations and is linked to other health effects such as skin damage and circulatory problems.

Glendale Heights UCMR 3 Testing

In 1996 amendments to the Safe Drinking Water Act (SDWA) require that once every five years, the U.S. Environmental Protection Agency (EPA) issue a new list of no more than 30 unregulated contaminants to be monitored by public water systems (PWSs). The Unregulated Contaminant Monitoring Rule (UCMR) provides EPA and other interested parties with scientifically valid data on the occurrence of contaminants in drinking water. These data serve as a primary source of occurrence and exposure information that the agency uses to develop regulatory decisions.

The Village of Glendale Heights is classified under the UCMR 3 as an Assessment Monitoring (List 1) community, and is monitoring for 21 chemicals in 2015 as a part of the UCMR monitoring requirements established in 1996 by the U.S. EPA. These results are seen in the table below:


