Approval of Regular Meeting Minutes 9/18/18

Enrique Arroyo motioned to approve. Trustee Maritato seconded the motion. Minutes approved.

Discussion Regarding – Pool Analysis

Director Knautz stated that proposals went out to complete an analysis of our pool equipment to assist in future planning and replacement of equipment. Innovative Design was hired by the Village and they came out to inspect while the pool was in operations and when it was closed. The findings were that the facility has been well maintained and they suggested that the heater for the plunge pool has another 3 to 5 years left. They also stated the pumps run at ½ power and that they are too large for the pool. Their recommendation is to have an assessment every 5 years.

Discussion Regarding – Program Updates

GHYBS - 74 participants for the fall league. 14U boys finished top in their tournament.

Spartans - season ended with their 12-6 loss in the Super Bowl. End of season party was held on November 15 at Enchanted Castle.

Indoor Soccer - currently halfway through the season. 210 individual registrations and 10 team registrations, which is a 41% increase from last year. We have an over 55 league running on Sunday nights. The new indoor turf is holding up well and grooming is performed weekly.

PATH - currently has 174 students enrolled.

Men's Mini Basketball League - currently running with 14 teams. We are anticipating 26 teams for the winter season.

The 2019 Winter/Spring Brochure will be out in the mail in the next few weeks.

Discussion Regarding – Rec-in the Hub Event

On Saturday, January 26th, we are hosting an event called Rec-in the Hub. This replaces what was previously Sports, Fit and Fun Field Day. At this event we will be showcasing programs, offering demonstrations, discounted registrations, door prizes and supplying breakfast. The goal is to get residents into the Hub and experience a little bit of everything that we have to offer. We will be hosting another event in May that will be called Hubapalooza which will showcase summer offerings.

Discussion Regarding – Controlled Burns

We will be performing controlled burns at the Civic Center and Reskin Park. These were scheduled to be completed in November but because of weather, they have been postponed. They may get pushed back until Spring, depending upon weather conditions.
