# **Man Charged with Aggravated Vehicular Hijacking and Armed Robbery**

Glendale Heights, IL – On Friday, June 3, 2022 Glendale Heights Police arrested Isaiah B Sanders and charged him with one (1) count of Aggravated Vehicle Hijacking, one (1) count of Armed Robbery, one (1) count of Unlawful Use of a Weapon by a Felon and two (2) counts of Aggravated Battery.

On Monday, May 30, 2022 at approximately 3:03 am, the Glendale Heights Police Department responded to the 500 block of James Ct for a report of a subject, who was stabbed with a knife and had his vehicle stolen. The victim was able to provide a description of his vehicle and the suspect to the responding officers, who located the offender inside the victim's vehicle and still in the area. Upon seeing the responding officers, the offender fled on foot. Officers recovered the victim's vehicle but were unable to locate the offender. The offender took some of the victim's property when he fled the area. The victim, who was treated at a hospital and released, reported he was inside his vehicle with a female companion when the suspect opened the door and attacked him. Both the victim and his female companion fled the area as the suspect drove off with the victim's vehicle. During the attack, the victim received several stab wounds to his hand and leg. Both the victim and his female companion fled the area as the suspect drove off with the victim's vehicle. The victim's female companion was not injured during the incident.

The investigation identified the offender as 26 year-old, Isaiah B Sanders. On Friday, June 3, 2022, investigators with the assistance of M.E.R.I.T SWAT executed a search warrant at Sanders' home in the 300 block of Coventry Lane in Crete, IL. During the execution of the search warrant, investigators took Sanders into custody and recovered the victim's property.

The DuPage County State's Attorney reviewed the facts of the investigation and felony charges were approved against Isaiah B Sanders.

Isaiah B Sanders was taken to the DuPage County Jail where he is presently being held for bond court.
